RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "**Release**") is made as of July 20, 2010 ("**Effective Date**") by and between Texas ACP I, L.P., a Texas limited partnership ("**Lender**") and Safety Tubs Holdings, LLC, a Florida limited liability company, with its principal office at 1100 Ave S., Grand Prairie, Texas 75050 ("**Grantor**").

WHEREAS, pursuant to the terms and conditions of that certain Acknowledgement of Intellectual Property Collateral Lien by and between Grantor and Lender dated December 29, 2008 (the "**Trademark Security Agreement**"), Grantor pledged and granted to Lender a continuing security interest in and to all of Grantor's right, title and interest in and to the United States trademark registrations and applications set forth on Schedule A attached hereto, together with the goodwill of the business connected therewith (collectively, the "**Trademarks**"); and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("**PTO**") on February 2, 2009, at Reel 3933, Frame 0651.


NOW, THEREFORE, Lender hereby grants, assigns and conveys to Grantor all of its rights, title and interest in the Trademarks, and terminates, cancels and releases any and all security interests or liens it has against the Trademarks.

Lender shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
