RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

Harris NA (as successor to Harris Trust and Savings Bank ("Harris Trust")) enters into this Release of Security Interests in Intellectual Property (the "Release") as of July 21, 2010, in favor of Interactive Data Corporation, ("IDCO"), a Delaware corporation, having its principal business address at 32 Crosby Drive, Bedford, MA 01730.

Introduction

A. FutureSource/Bridge LLC ("FutureSource") and Harris Trust entered into that certain Security Agreement Re: Intellectual Property dated March 9, 1999 (the "Security Agreement"). Unless otherwise defined in this Release, all capitalized terms it uses shall have the meanings given them in the Security Agreement.

B. Pursuant to the Security Agreement, FutureSource granted to Harris Trust interests (the "Security Interest") in the Patents, Trademarks, and Copyrights (the "Intellectual Property"), including but not limited to the Trademarks listed on the attached Schedule A.

C. The United States Patent and Trademark Office ("PTO") recorded an Assignment for Security against the United States Trademarks on March 16, 1999 at Reel 1871; Frame 0504;

D. IDCO acquired all of the assets of FutureSource, including the Intellectual Property, on September 1, 2004.

E. Harris Trust agrees and acknowledges that there are no outstanding obligations under the Security Agreement and releases and reassigns to IDCO any and all of its security interests in the Intellectual Property, including but not limited to the Trademarks listed on the attached Schedule A. The parties seek to make a record of that release and reassignment.


Terms

Now, therefore, in consideration of the foregoing recitals, and for other good and valuable consideration, the receipt and adequacy of which Harris Trust acknowledges, it hereby:

- (i) Releases, discharges, and relinquishes its security interests in the Intellectual Property; and
- (ii) Reassigns to IDCO any and all right, title and interest that it may have had in the Intellectual Property.

Harris Trust specifically acknowledges that the Security Agreement is no longer effective and that it does not own any rights to or have any ownership interest in the Intellectual Property, and all of its rights and remedies with respect to the Intellectual Property have been and are now extinguished. Moreover, Harris Trust specifically acknowledges that this Release applies to for the benefit of IDCO.

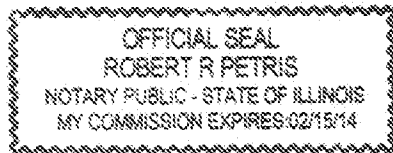


