SMobile Systems, Inc., a corporation organized and existing under the laws of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: That the name and jurisdiction of formation or organization of each of the constituent entities which are to merge are as follows:

<u>Name</u>	<u>Jurisdiction of Incorporation</u>
SMobile Systems, Inc.	Delaware
S Mobile Systems, Inc.	Ohio

SECOND: That an Agreement and Plan of Merger (the "Merger Agreement"), dated July 21, 2010, has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations, namely S Mobile Systems, Inc., an Ohio corporation ("SMobile Ohio"), and SMobile Systems, Inc., a Delaware corporation ("SMobile Delaware"), in accordance with subsection 252(c) of the General Corporation Law of the State of Delaware (the "DGCL").

THIRD: That SMobile Delaware shall be the surviving corporation, and that the certificate of incorporation of SMobile Delaware, as in effect at the effective time of the merger, shall be the certificate of incorporation of the surviving corporation.

FOURTH: That the executed Merger Agreement is on file at an office of the surviving corporation, located at 4320 East 5th Avenue, Columbus, OH 43219 and a copy of the Merger Agreement will be furnished by the surviving corporation, upon request and without cost, to any stockholder of any constituent corporation.

FIFTH: The authorized capital stock of SMobile Ohio, the merging corporation, consists of 1,500 shares of common stock, without par value.
