TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment, is dated as of July 20, 2010, and entered into by DEUTSCHE BANK TRUST COMPANY AMERICAS (as successor-in-interest to Bankers Trust Company) ("Deutsche Bank"), in favor of CITY DIRECTORIES, INC. (the "Company").

WITNESSETH:

WHEREAS, pursuant to a Grant of Security Interest in United States Trademarks and Patents (the "Security Agreement"), dated as of October 15, 2001, by the Company in favor of Bankers Trust Company, as collateral agent (the "Collateral Agent") and recorded with the U.S. Patent and Trademark Office on October 24, 2001 at Reel/Frame No. 002432/0606, the Company granted the Collateral Agent a security interest in and to all of its rights, title and interest in various trademarks and applications and registrations set forth on Schedule A attached hereto (the "Trademark Collateral"); and

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


