**TRADEMARK RELEASE AND REASSIGNMENT**

This Trademark Release and Reassignment, is dated as of July 20, 2010, and entered into by DEUTSCHE BANK TRUST COMPANY AMERICAS (as successor-in-interest to Bankers Trust Company) ("Deutsche Bank"), in favor of IDEXEC, INC. (the "Company").

**WITNESSETH:**

WHEREAS, pursuant to a Grant of Security Interest in United States Trademarks and Patents (the "Security Agreement"), dated as of May 3, 2000, by the Company in favor of Bankers Trust Company, as collateral agent (the "Collateral Agent") and recorded with the U.S. Patent and Trademark Office on August 30, 2000 at Reel/Frame No. 002153/0673, the Company granted the Collateral Agent a security interest in and to all of its rights, title and interest in various trademarks and applications and registrations set forth on Schedule A attached hereto (the "Trademark Collateral"); and

WHEREAS, the Company has requested that Deutsche Bank as successor-in-interest to the Collateral Agent release its security interest in the Trademark Collateral granted pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


1. Deutsche Bank hereby releases its security interest in all of the Company's rights, title and interest in and to all of the Trademark Collateral, including without limitation the security interest granted by the Security Agreement, the trademark registrations and applications referred to in Schedule A attached hereto, and the goodwill of the Company's business connected with the use of and symbolized by the Trademark Collateral.

2. Deutsche Bank hereby reassigns, grants and conveys to the Company all of Deutsche Bank's rights, title and interest in and to the Trademark Collateral including without limitation the trademark registrations and applications referred to in Schedule A attached hereto, and the goodwill of the Company's business connected with the use of and symbolized by the Trademark Collateral.
