

## TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment, is dated as of July<sup>21</sup>, 2010, and entered into by DEUTSCHE BANK TRUST COMPANY AMERICAS (as successor-in-interest to Bankers Trust Company) ("Deutsche Bank"), in favor of INFOUSA, INC. (the "Company").

### WITNESSETH:

WHEREAS, pursuant to a Grant of Security Interest in United States Trademarks (the "Security Agreement"), dated as of October 25, 2000, by the Company in favor of Bankers Trust Company, as collateral agent (the "Collateral Agent") and recorded with the U.S. Patent and Trademark Office on February 27, 2001 at Reel/Frame No. 002247/0359, the Company granted the Collateral Agent a security interest in and to all of its rights, title and interest in various trademarks and applications and registrations set forth on Schedule A attached hereto (the "Trademark Collateral"); and
