**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of July 27, 2010 (the "Release") is made by UNION BANK, N.A. (f/k/a Union Bank of California, and referred to herein as, "UBOC"), in favor of ENTRAVISION COMMUNICATIONS CORPORATION, a Delaware corporation ("Entravision") as follows:

**WITNESSETH**

WHEREAS, Entravision is a party to a Trademark Security Agreement, dated as of September 29, 2005 (as amended, restated or otherwise modified, the "Trademark Security Agreement"), and recorded with the United States Patent and Trademark Office on October 5, 2005 at Reel/Frame No. 3170/0660, pursuant to which Entravision pledged and granted to UBOC a security interest in all of its right, title and interest in, to and under the Trademark Collateral (as defined therein), including without limitation (a) all United States, state and foreign trademarks, trade names, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certifications marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, all registrations and applications for any of the foregoing, including, but not limited to: (i) the registrations and applications referred to on Schedule I thereto (ii) all extensions or renewals of any of the foregoing, (iii) all of the goodwill of the business connected with the use of and symbolized by the foregoing, and (iv) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill, (b) any and all agreements providing for the granting of any right in or to the foregoing and (c) all proceeds of the foregoing, including, without limitation, licenses, royalties, income payments, claims, damages and proceeds of suit, in each case whether then existing or thereafter created or acquired (collectively, the "Released Trademark Collateral")

WHEREAS, UBOC acknowledges that full payment, complete performance and satisfaction of all obligations pursuant to the Trademark Security Agreement have been made;


WHEREAS, Entravision has requested that UBOC release its security interest in and to the Released Trademark Collateral, including without limitation the trademarks and all applications and registrations therefor set forth in Schedule A attached hereto and incorporated herein by this reference

NOW, THEREFORE, in consideration of the foregoing, UBOC, without recourse, representation or warranty and at Entravision's sole cost and expense, hereby RELEASES all of its right, title and interest in, to and under, the Released Trademark Collateral, including without limitation the trademarks set forth in Schedule A attached hereto and any other collateral described in the Trademark Security Agreement.

UBOC agrees to provide Entravision with any information and additional authorization necessary to effect the release of UBOC's security interest in the Released Trademark Collateral.
