**CERTIFICATE OF AMENDMENT TO THE
SIXTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF
WATERCOOLER, INC.,
a Delaware corporation**

WaterCooler, Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware DOES HEREBY CERTIFY:

FIRST: That the name of this corporation is Watercooler, Inc.

SECOND: That the original Certificate of Incorporation of WaterCooler, Inc. was filed with the Secretary of State of Delaware on September 29, 2006.

THIRD: That the Board of Directors duly adopted, pursuant to Sections 141(f) and 242 of the General Corporation Law of the State of Delaware, resolutions setting forth an amendment to the Sixth Amended and Restated Certificate of Incorporation of the Corporation (the "*Restated Certificate*") and declaring said amendment to be advisable and in the best interests of this corporation and its stockholders. The stockholders of the Corporation duly approved said proposed amendment by written consent in accordance with Sections 228 and 242 of the General Corporation Law of the State of Delaware.

FOURTH: The Restated Certificate is hereby amended by deleting the text of Article FIRST in its entirety and substituting the following therefor:

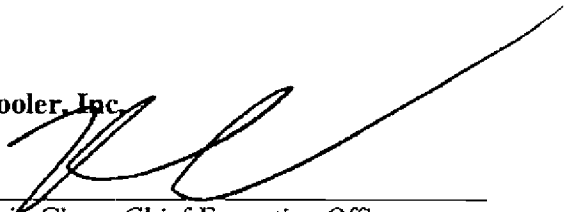
"The name of the corporation (hereinafter called the "*Corporation*") is Kabam, Inc."

FIFTH: Except as modified hereby, the Restated Certificate shall remain in full force and effect.
