## AMENDED AND RESTATED ASSIGNMENT OF TRADEMARKS

This agreement is executed as of the day set forth on the signature page hereto but made effective as of May 12, 2009 by and between **Stacey L. Meisel**, in her capacity as Chapter 7 Trustee for the Estate of **Home Décor Products, Inc.**, a Delaware corporation ("Assignor") and **Homeclick LLC** ("Assignee").

### RECITALS:

**WHEREAS**, Assignor and Assignee entered into that certain Asset Purchase Agreement, dated April 28, 2009 (the "Agreement") which provides for, among other things, the sale, assignment and transfer of all of Assignor's right, title and interest in and to all trademarks and service marks, used in connection with Assignor's business, including, but not limited to, those described on **Schedule A** (hereinafter collectively referred to as the "Marks"); and

**WHEREAS**, Assignor desires to assign and transfer to Assignee and Assignee desires to accept and receive from Assignor, any and all rights that Assignor may have in and to the Marks and any registrations relating thereto, together with the goodwill of the business in connection with which the Marks are used and which is symbolized by such Marks, along with the right to recover for damages and profits for infringements thereof arising after the date hereof.

**NOW, THEREFORE**, in consideration of and in exchange for the consideration set forth in the Agreement, and for other good and valuable consideration contained herein, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. Assignor does hereby irrevocably assign, sell, transfer and deliver to Assignee, its successors and assigns, its entire right, title and interest in and to: (a) the Marks, and any registrations and renewals thereof, (b) all goodwill symbolized by and associated with the business conducted under such Marks and any part thereof, and (c) all income, royalties, judgments and payments hereafter due to Assignor or payable in respect of any causes of action, whether in law or in equity, for future infringement based on said Marks.
2. Assignor agrees to execute and deliver at the reasonable request of the Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to: (a) vest all Assignor's rights, title, and interest in and to the Marks in the Assignee, and (b) provide evidence to support Assignee's rights in the Marks.
3. This Assignment of Trademarks is being delivered in connection with the closing of the transactions contemplated by the Agreement and is subject to the terms, conditions and limitations set forth therein. In the event of any conflict or inconsistency between the terms of the Agreement and the terms hereof, the terms of the Agreement shall govern.
4. Assignor and Assignee acknowledge that the foregoing assignment is being made in connection with a transaction through which Assignee has acquired, among other things, the entire business lines of Assignor relating to the following marks and associated applications at the United States Patent and Trademark Office (collectively, the "Intent-to-Use Marks"): (i) 78/637797 ("Diamond Bay"), (ii) 78/637805 ("Diamond Bay Fan Company"), (iii) 78/730055 ("Harry Homeowner"), (iv) 78/637810 ("Yard Star") and (v) 78/898020 ("Hechinger"). Following said transaction, Assignee succeeded to the entire business lines to which the Intent-to-Use Marks pertain, such business lines being ongoing and existing.





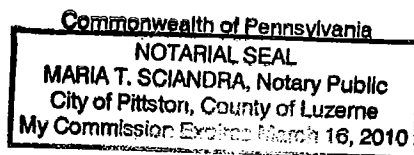
