RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made effective as of July 29, 2010 by SQUARE 1 BANK (the "Lender"), to HYPERBRANCH MEDICAL TECHNOLOGY, INC., a Delaware corporation (the "Grantor"), as follows:
