RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of July 29, 2010 (the "Effective Date"), by ORIX FINANCE CORP., as administrative agent for itself and the lenders from time to time signatory to the Credit Agreement (as defined herein) (collectively, the "Lender").

WHEREAS, the Lender and MCMC LLC, MCMC HOLDINGS LLC, COUNTRY-WIDE INDEPENDENT EXAMS, LLC, MBA HOLDCO, LLC, LITIGATION SOLUTIONS, LLC (collectively, the "Grantors") are parties to that certain Credit Agreement dated as of December 21, 2007 among the Lender and the Grantors, as amended (the "Credit Agreement");

WHEREAS, pursuant to the Credit Agreement, the Lender and the Grantors entered into that certain Intellectual Property Security Agreement dated as of December 21, 2007 (the "Security Agreement") among the Grantors and the Lender, pursuant to which the Grantors granted to the Lender a security interest in and lien on (a) certain Patents and Patent licenses set forth on Schedule I attached hereto (the "Patent Collateral"), (b) certain Trademarks and Trademark Licenses set forth on Schedule II attached hereto (the "Trademark Collateral") and (c) certain Copyrights and Copyright Licenses set forth on Schedule III attached hereto (the "Copyright Collateral") (collectively, the "IP Collateral");

WHEREAS, the Security Agreement was recorded in the U.S. Trademark Office - Assignment Division on August 7, 2008 at Reel/Frames 3831/0441 and 3831/0415, and on August 11, 2008 at V3568 D634 P1-13; and

WHEREAS, the Lender agrees to formally release and re-convey to the Grantors the security interest in all of Grantors' right, title and interest in and to the IP Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender does hereby fully release and discharge its security interest in and lien on the IP Collateral, including, without limitation, the patents, trademarks and copyrights listed in Schedule I, Schedule II and Schedule III attached hereto, the debt secured thereby having been discharged in full, and assigns to the Grantors any and all right, title and interest in and to the IP Collateral and the goodwill associated therewith that it may have.
