**ASSIGNMENT AND ASSUMPTION AGREEMENT**

THIS ASSIGNMENT AND ASSUMPTION AGREEMENT (this "Agreement") is dated as of July 28, 2010 and is made by SIX FLAGS THEME PARKS INC., a Delaware corporation ("Assignor"), as assignor, to KKI, LLC, a Delaware limited liability company ("Assignee"), as assignee.

1. Assignor hereby grants, conveys, assigns and transfers unto Assignee, all of its right, title and interest in and to that certain trademark "KENTUCKY KINGDOM," U.S. Trademark Registration No. 2,889,287, and the goodwill associated therewith (the "Mark"), subject only to all existing liens and encumbrances pursuant to that certain (a) First Lien Credit Agreement, dated as of April 30, 2010, among Six Flags Entertainment Corporation (formerly known as Six Flags, Inc.) ("Parent"), Six Flags Operations Inc., Assignor, the several banks and other financial institutions or entities from time to time parties thereto, and JPMorgan Chase Bank, N.A., as administrative agent, and (b) Second Lien Credit Agreement, dated as of April 30, 2010, among Parent, Six Flags Operations Inc., Assignor, the several banks and other financial institutions or entities from time to time parties thereto, and Goldman Sachs Lending Partners LLC, as administrative agent.

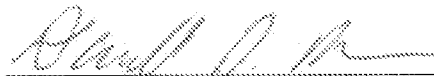
2. Assignee hereby accepts the assignment of the Mark pursuant to the terms hereof.

3. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. This Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.

IN WITNESS WHEREOF, the parties have executed and delivered this Agreement as of the date set forth above.

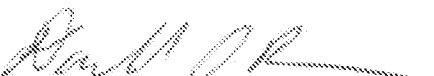
