RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain Trademark Security Agreement, dated November 3, 2005 (as amended by that certain Amendment Number One to Trademark Security Agreement, dated as of July 19, 2006, that certain Amendment Number Two to Trademark Security Agreement, dated as of June 26, 2007, and that certain Amendment Number Three to Trademark Security Agreement, dated as of March 9, 2009) (collectively, the “Trademark Security Agreement”), recorded in the United States Patent and Trademark Office at Reel 003187/Frame 0815, Reel 003353/Frame 0234, Reel 003568/Frame 0687, and Reel 003948/Frame 0403, respectively, whereby Register.com, Inc., (“Releasee”) granted to Ableco Finance LLC (“Releasor”) a security interest in all right, title and interest of Releasee in and to the trademark registrations and applications listed on Schedule A attached hereto (the “Trademarks”); and

Releasor hereby agrees to duly execute and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby, at the sole cost and expense of the Releasee.
