TERMINATION AND RELEASE OF SECURITY INTEREST IN

INTELLECTUAL PROPERTY

This Termination and Release of Security Interest in Intellectual Property (the "<u>Termination and Release</u>"), is made as of July 30, 2010, by R.H. BOOK, LLC, a New Jersey limited liability company ("<u>Secured Party</u>"), in favor of S MOBILE SYSTEMS, INC., an Ohio corporation ("<u>Grantor</u>").

RECITALS

- A. - C. The Trademark Security Agreement was filed with the United States Patent and Trademark Office, Trademark Division, on April 15, 2010, at Reel/Frame 4186/0828 to evidence the security interest in certain trademarks and trademark applications granted thereunder.
- D. Grantor has satisfied all obligations under the Amended and Restated Secured Promissory Note, dated as of April 13, 2010, issued by Grantor to Secured Party and as a result, Grantor has requested, and Secured Party has agreed, to release its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party agrees as follows:

- 1. Secured Party hereby expressly confirms the termination and release to Grantor of its security interest, and entire interest, in and to all Collateral, including the intellectual property rights below:
- (a) All of Grantor's right, title and interest in and to all of its now or in the future owned or existing patents and patent applications, including the inventions and improvements described and claimed in any patents and patent applications (collectively, the "Patents"), all reissues, divisions, continuations, renewals, extensions and continuations-in-part of each of the Patents, all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all of the Patents, including damages and payments for past or future infringements of any and all of the Patents, all rights to sue for past, present and future infringements of any and all of the Patents, all rights corresponding to any and all of the Patents throughout the world, and all rights of Grantor as licensor or licensee under, and with respect to, any patents or patent applications, including Patent Licenses (as defined in the Patent Security Agreement), including, without limitation, the patents and patent applications set forth on Exhibit A attached hereto; and
- (b) All of Grantor's right, title and interest in and to all of its now or in the future owned or existing trademarks, service marks, trademark or service mark registrations, trade names, and trademark or service mark applications, (collectively, the "Trademarks"), all renewals of each of the

Trademarks, all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all of the Trademarks, including damages and payments for past or future infringements of any and all of the Trademarks, all rights to sue for past, present and future infringements of any and all of the Trademarks, all rights corresponding to each of the Trademarks throughout the world, all rights of Grantor as licensor or licensee under, and with respect to, trademarks, service marks, trade names, and trademark and service mark applications, including Trademark Licenses (as defined in the Trademark Security Agreement), and together in each case with the goodwill of Grantor's business connected with the use of, and symbolized by, the foregoing, including, without limitation, the trademarks and trademark applications set forth on Exhibit B attached hereto.

2. Secured Party authorizes and requests that the Commissioner for Patents and Trademarks, and any other government officer record this Termination and Release.
