THIS AGREEMENT is made on 1 April 2008

BETWEEN:

- (1) **FINE FRAGRANCES AND COSMETICS LIMITED**, a limited liability company incorporated under the laws of England and Wales, with company number 01967340, whose registered office is at 22 Grimrod Place, Skelmersdale, Lancashire, WN8 9UU (the *Seller*); and
- (2) **VIVALIS LIMITED**, a limited liability company incorporated under the laws of England and Wales, with company number 01462595, whose registered office is at 22 Grimrod Place, Skelmersdale, Lancashire, WN8 9UU (the *Purchaser*).

WHEREAS:

(A) The Seller is a sales, marketing and distribution company operating in the fragrances, hair care and skincare sectors (the *Business*),

(B) The Seller has agreed to sell the Business (as defined above) to the Purchaser for the consideration and upon the terms and conditions set out in this agreement.

NOW IT IS AGREED as follows:

1. DEFINITIONS

1.1 Words and expressions used in this Agreement shall have the meanings set out in Schedule I, unless the context requires otherwise.

1.2 The Schedules comprise all the schedules to this Agreement and form part of this Agreement and shall have the same force and effect as if set out in the body of this Agreement. Any reference to this Agreement shall include all Schedules.

2. AGREEMENT TO SELL AND PRICE

2.1 Subject to Clause 2.4 below, the Seller hereby sells, transfers and assigns (or shall procure the sale, transfer and assignment of), and the Purchaser hereby purchases and accepts, such right, title and interest (if any) as the Seller may have in the Business as a going concern, which includes the following *Business Assets*:

- (a) the Stock;
- (b) the Trade Receivables;
- (c) the benefit (subject to the burden) of all Contracts which remain outstanding in whole or in part at the date of this Agreement;
- (d) the loose Plant and Equipment;
- (e) the Employees;
- (f) the benefit of all Claims subsisting at the date of this Agreement.

- (g) the Information;
- (h) the Trade Mark Assets (subject to the terms and conditions of the Trade Mark Licences and any licences granted to third parties);
- (i) the Business Intellectual Property Rights; and
- (j) the Goodwill.

but, for the avoidance of doubt, does not include the Excluded Assets and the Excluded Liabilities.

2.2 In consideration for the sale, transfer and assignment by the Seller of the Business (including the Business Assets), the Purchaser shall:

- (a) pay to the Seller the sum of \$ [REDACTED] and [REDACTED];
- (b) assume responsibility for the satisfaction of all the Liabilities (other than the Excluded Liabilities).

2.3 The Purchaser shall indemnify and hold the Seller harmless from and against all proceedings, claims, actions, demands, obligations, damages, losses, costs and expenses which the Seller may suffer or incur in respect of the Liabilities.

2.4 The Seller and the Purchaser hereby agree that, notwithstanding the transfer detailed in this clause, the Business Assets are transferred subject to the security described in the Security Documents and there shall be no release of the Business Assets from all or any part of that security.

3. EXCLUDED ASSETS AND LIABILITIES

3.1 The Purchaser acknowledges that it is not purchasing or receiving the Excluded Assets or the Excluded Liabilities, which are excluded from the sale and purchase under this Agreement.

3.2 Nothing in this Agreement shall operate to transfer any of the Excluded Assets to the Purchaser or make the Purchaser liable for any of the Excluded Liabilities, provided that the Purchaser and the Seller shall, with respect to any assets that were, in the reasonable opinion of the Seller and the Purchaser, accidentally not included as part of the Business Assets, whilst they were assets forming part of the ordinary course of the Business, enter into good faith negotiations with respect to the terms and conditions on which those assets may be transferred to the Purchaser.

4. CLOSING

4.1 The sale and purchase of the Business Assets shall be completed immediately after this Agreement is signed (Closing), when the events detailed in the remainder of this Clause 4 shall take place.

4.2 On Closing, the Seller shall cause to be delivered or made available to the Purchaser:

- (a) such documents as the Purchaser may reasonably require to complete the sale and purchase of the Business Assets, together with all deeds and documents of title relating thereto;
- (b) without limitation to the above, Trade Mark Assignment Deeds in substantially the form set out in Schedule 9 in respect of all of the Trade Mark Assets, duly executed by the relevant assignor;
- (c) possession of such of the Business Assets as are tangible including:
 - (i) all information (whether in computerised or other form) relating to the Business; and
 - (ii) all the designs and drawings, plans, manufacturing data, research and development data, prototypes, research materials, technical and sales publications, advertising material, computer media and other technical and sales matter of the Seller in relation to the Business, together with any plans, blocks, negatives and other like material relating thereto.

4.3 The cash sum referred to in Clause 2.2(a) above shall be left outstanding as a debt payable on demand in writing made by the Seller to the Purchaser at any time after the date of this Agreement and shall bear interest at a rate to be agreed from time to time between the parties.

4.4 If and to the extent that any documents of transfer are not available at Closing, the parties shall arrange for appropriate transfer documents to be prepared and completed as soon as practicable after Closing.

5. TITLE AND SUPPLEMENTARY PROVISIONS

5.1 Beneficial ownership and risk in respect of the Business Assets shall pass to the Purchaser on Closing. Title to all Business Assets which can be transferred by delivery shall pass on delivery and such delivery shall be deemed to take place at the offices of the Seller at 22 Grimrod Place, Skelmersdale, Lancashire, WN8 9UU on Closing.

5.2 Insofar as the Business Assets comprise the benefit of Claims and the benefit (subject to the burden) of Contracts which cannot effectively be assigned or transferred by the Seller to the Purchaser except by agreements of novation or without obtaining a consent, an approval, a waiver or the like from a third party (Consents):

- (a) the Seller shall (upon the request of the Purchaser) take all reasonable steps to procure that such Contracts are novated or the necessary Consents obtained and the Purchaser shall co-operate with the Seller for such purpose;
- (b) unless or until each of such Contracts shall have been so novated or assigned or any necessary Consent obtained, the Seller shall from the date of Closing receive and hold the benefit of the relevant Contract or Claim as trustee on trust for the Purchaser and shall pay to the Purchaser promptly upon receipt any sums received by it under any such Contract or pursuant to any such Claim.

(c) the Purchaser shall from the date of Closing (at the Purchaser's cost) assist the Seller to perform all the obligations of the Seller under any such Contracts and indemnify the Seller on an after-tax basis against all liability (and all costs reasonably incurred by the Seller) arising in connection with any such Contracts.

5.3 The Seller shall (at the expense, and with the assistance, of the Purchaser) take all reasonable steps to obtain as soon as reasonably practicable from the date of this Agreement any consent from the Trade Mark Licensor to the extent necessary to procure a licence of the Licensed Trade Marks to the Purchaser or an assignment or sub-licence of the Trade Mark Licences to the Purchaser.

5.4 The Seller shall with all due diligence execute such other documents and take such other steps as the Purchaser may reasonably require to vest the title to the Business Assets in the Purchaser and to give effect to this Agreement.

6. EMPLOYEES

6.1 The parties acknowledge and agree that the sale of the Business from the Seller to the Purchaser is a "relevant transfer" within the meaning of TUPE.

6.2 The Purchaser agrees that it shall bear any costs, claims, damages, penalties, compensation awards or expenses arising out of or in relation to the transfer of the Employees from the Seller, including but not limited to any liabilities attributable to the termination of the employment of any of the Employees, and shall indemnify the Seller in relation to the same.

7. TAX

7.1 Any sum payable under this Agreement is exclusive of Value Added Tax.

7.2 In the event that the Purchaser is not a member of the same VAT group as the Seller for the purposes of section 43(1) of the Value Added Tax Act 1994 (VATA) at Closing, the Seller and the Purchaser shall use all reasonable efforts to ensure that the transfer of the Business is treated as a transfer of a business as a going concern for the purposes of section 49 VATA and article 5 of The Value Added Tax (Special Provisions) Order 1993, including the making by the Purchaser of any election to waive exemption that may be required for this purpose.

7.3 The Seller shall, on Closing, deliver to the Purchaser all VAT Records and shall not make any request to HM Revenue & Customs for the VAT Records to be preserved by the Seller rather than the Purchaser.

7.4 The Seller and the Purchaser shall use their reasonable endeavours to ensure that a joint election is made under section 266 of the Capital Allowances Act 2001 and that written notice of such election is given to HM Revenue & Customs within two years following Closing.

8. COSTS AND EXPENSES

8.1 Unless otherwise stated in this Agreement, each Party shall be responsible for its own costs, charges and expenses in relation to the negotiations leading up to the

8.2 All stamp duty, any duty or charges incurred in connection with any anti-trust clearances, governmental or supra-governmental approvals, filings and the like, and any registration fees arising in respect of or in connection with this Agreement and the implementation thereof, shall be for the account of the Purchaser.

9. ENTIRE AGREEMENT

This Agreement sets out the entire agreement and understanding between the parties in respect of the sale and purchase of the Business. It is agreed that:

- (a) no party has entered into this Agreement in reliance upon any representation, warranty or undertaking of any other party which is not expressly set out or referred to in this Agreement;
- (b) save as expressly provided, and to the extent they may be excluded by contract, this agreement excludes any warranty, covenants, condition or undertakings which may be implied by law (including, without limitation, all terms and conditions which are implied under the Sale of Goods Act in a contract of sale of goods to which that Act applies, save for section 12 thereof);
- (c) a party may shall have no claim or remedy under this Agreement in respect of misrepresentation (whether negligent or otherwise, and whether made prior to, and/or in, this Agreement) or untrue statements made by the other party;
- (d) this clause shall not exclude any liability for, or remedy in respect of, fraudulent misrepresentation.

10. COUNTERPARTS

This Agreement may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which is an original but all of which together constitute one and the same instrument.

11. FURTHER ASSURANCE

The Seller shall, at the cost of the Purchaser, perform (or procure the performance of) all further acts and things, and execute and deliver (or procure the execution and delivery of) such further documents, as may be required by law or as the Purchaser may reasonably require, whether on or after Closing, to implement and/or give effect to this Agreement and the transaction contemplated by it and for the purpose of vesting in the Purchaser the full benefit of the assets, rights, title and benefits to be transferred to the Purchaser under this Agreement, including executing as soon as reasonably practicable any deeds, agreements or other documents required by the Purchaser to effect registration or recordal of the assignment of any Trade Marks to the Purchaser in any jurisdiction.

No variation of this Agreement (or of any of the documents referred to in this Agreement) shall be valid unless it is in writing and signed by or on behalf of each of the parties to it. The expression "variation" shall include any variation, supplement, deletion or replacement however effected.

14. FORCE MAJEURE

Neither party shall be liable for any failure or delay in performing any of its obligations under this agreement if the failure or delay is due to any cause beyond its reasonable control, and it shall be entitled to a reasonable extension of the time for performing the obligations as a result of the cause.

15. NO RIGHTS UNDER CONTRACTS (RIGHTS OF THIRD PARTIES) ACT 1999

A person who is not a party to this Agreement shall have no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any of its terms.

16. GOVERNING LAW

16.1 This Agreement and the relationship between the parties shall be governed by, and interpreted in accordance with, English law.

16.2 Except as expressly provided otherwise in this agreement, the courts of England are to have exclusive jurisdiction to settle any disputes which may arise in connection with this agreement. For such purposes each party irrevocably submits to the jurisdiction of the English courts, waives any objections to the jurisdiction of those courts and irrevocably agrees that a judgment or order of the English courts in connection with this agreement is conclusive and binding on it and may be enforced against it in the courts of any other jurisdiction.

Trade Mark Licences means the existing licences from the Trade Mark Licensor to the Seller in respect of the usage of the Licensed Trade Marks;

Trade Mark Licensor means IWP Ireland Limited;

Trade Marks means those trade mark registrations and applications for registrations listed in Schedule 2 and all statutory and common law rights attaching to the Trade Marks;

TUPE means the Transfer of Undertakings (Protection of Employment) Regulations 2006;

VAT Records means all records referred to in section 49 of the VATA; and

VATA has the meaning given in clause 7.2.

2. In this Agreement, unless otherwise specified:
- (a) references to recitals, clauses, Schedules and Annexes are to recitals, clauses, Schedules and Annexes to this Agreement;
 - (b) a reference to any statute or statutory provision shall be construed as a reference to the same as it may have been, or may from time to time be, amended, modified or re-enacted except to the extent that any amendment or modification made after the date of this Agreement would increase or alter the liability of the Vendors under this Agreement;
 - (c) references to a person shall be construed so as to include any individual, firm, company, government, state or agency of a state or any joint venture, association or partnership (whether or not having separate legal personality);
 - (d) references to writing shall include any modes of reproducing words in a legible and non-transitory form;
 - (e) references to times of the day are to London time; and
 - (f) headings to clauses, Schedules and Annexes are for convenience only and do not affect the interpretation of this Agreement.


