**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”), dated as of July 31, 2010, is made by **CIT LENDING SERVICES CORPORATION**, as administrative and collateral agent (the “**Agent**”), under the Omnibus Pledge and Security Agreement referred to below.

WHEREAS, Auto Crane Company (the “**Company**”) is a party to that certain Omnibus Pledge and Security Agreement, dated as of April 5, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the “**Omnibus Pledge and Security Agreement**”), made by the Company and the other pledgors named therein in favor of the Agent; and

WHEREAS, pursuant to the Omnibus Pledge and Security Agreement and that certain Security Agreement (Trademarks) dated as of April 5, 2007 (the “**Trademark Security Agreement**”) made by the Company in favor of the Agent, the Company granted to the Agent a security interest in the Collateral (as defined in the Trademark Security Agreement), including the Trademarks listed on Annex I attached hereto; and


WHEREAS, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on April 11, 2007, on Reel/Frame 003519/0917.

NOW THEREFORE, the Agent hereby releases, without representation, recourse or warranty whatsoever, its security interest in the Collateral granted pursuant to the Omnibus Pledge and Security Agreement or the Trademark Security Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Collateral to the Company.

The Agent agrees, at the Company’s expense, to cooperate with the Company to provide the Company with any additional information or authorization reasonably required or desirable to effect the release of the Agent’s security interest in the Collateral.
