

CERTIFICATE OF MERGER
OF
FILTRAN MERGERCO LLC
(a Delaware Limited Liability Company)
WITH AND INTO
SPX FILTRAN LLC
(a Delaware Limited Liability Company)

SPX FILTRAN LLC, a limited liability company organized under the laws of the State of Delaware, pursuant to Section 18-209 of the Delaware Limited Liability Company Act, as amended (the "Delaware LLC Act"), does hereby certify as follows:

1. The constituent business entities participating in the merger herein certified (the "Merger") are as follows:

(a) Filtran Mergerco LLC, a limited liability company which is organized under the laws of the State of Delaware ("Mergerco"); and

(b) SPX Filtran LLC, a limited liability company which is organized under the laws of the State of Delaware ("Filtran", also sometimes hereinafter referred to as "Survivor").

2. An Agreement and Plan of Merger has been approved, adopted, certified, executed, and acknowledged by each of the constituent limited liability companies in accordance with the provisions of subsection (b) of Section 18-209 of the Delaware LLC Act.

3. The name of the surviving limited liability company in the Merger is SPX Filtran LLC, which will continue its existence as Survivor under the name "Filtran LLC" upon the effective date of the Merger pursuant to the provisions of the Delaware LLC Act.

4. The Certificate of Formation of Filtran, as now in force and effect, is hereby amended to reflect the name change of the Survivor from SPX Filtran LLC to "Filtran LLC", and as so amended, shall continue to be the Certificate of Formation of the Survivor until further amended and changed pursuant to the provisions of the Delaware LLC Act.

5. The Merger shall be effective upon the filing of this Certificate.


