TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL
PROPERTY

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release") is dated as of July 15, 2010 (the "Release Date") by Silicon Valley Bank, as secured party (the "Secured Party"), for the benefit of SterilMed Repair Corp. (fka TSE Acquisition I Corp.) (the "Grantor").


