RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **July 26, 2010** (this "Release") is made by U.S. Bank National Association, a National Association, F/K/A Mercantile Bank of St. Louis, National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain Security Agreement granting a security interest in the trademark ARROWSTIK as Registration Number 1703008, dated as of **September 26, 1996** and recorded on October 22, 1996 at Reel 1521, Frame 0885, in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **Code 3 Holdings, Inc.**, (the "Debtor") and the Secured Party;

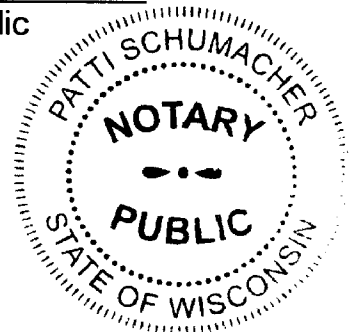
