**TRADEMARK RELEASE**

TRADEMARK RELEASE, effective as of this 28th day of December, 2006, given by DEUTSCHE BANK TRUST COMPANY AMERICAS, as Collateral Agent ("Agent") with principal offices at 60 Wall Street, New York, NY 10005 to Sunrise Medical, Inc., a Delaware corporation ("Grantor"), with principal offices at 2382 Faraday Avenue, Suite 200, Carlsbad, CA 92008, as follows:

**WITNESSETH**

WHEREAS, the Grantor has heretofore granted to the Agent a security interest in certain trademarks, trademark registrations and trademark applications (the "Marks") to secure the Obligations (as defined in that certain Security Agreement, dated as of May 13, 2004, between the Agent and the Grantor (the "Security Agreement")); and
