**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION OF
LANDLOCK HOLDINGS, INC.**

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

ARTICLE ONE

The name of the corporation is **LANDLOCK HOLDINGS, INC.**

ARTICLE TWO

The amendment to the articles of incorporation was adopted by the shareholders of **LANDLOCK HOLDINGS, INC.** by a written consent approved by the sole shareholder and dated January 20, 2002. The amendment changes article one of the original articles of incorporation, which shall read in its entirety as follows:

"The name of the corporation is **Landlock Seafood Company, Inc.**"

ARTICLE THREE

The number of shares of common stock of the corporation outstanding at the time of such adoption was *1,000* and the number entitled to vote therein was *1,000* shares.

ARTICLE FOUR

The number of shares voted in favor of the amendment to the articles of incorporation was *1,000* and the number of shares voted against the amendment to the articles of incorporation was *0*.
