RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of July 27, 2010 ("Effective Date") by Wells Fargo Bank, N.A. (as successor by merger to Wachovia Bank, National Association, the "Bank") in favor of Berkshire Blanket, Inc. (the "Pledgor").

WHEREAS pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of December 20, 2006 (the "Trademark Security Agreement,"), the Pledgor pledged and granted to the Bank a lien on and security interest in and to all of its right, title and interest in, to and under the Trademark Collateral, including, without limitation, the trademark registrations listed on Schedule I attached hereto which security interest has been recorded on December 28, 2006 at Reel 3451 Frame 0822 at the U.S. Patent and Trademark Office;

WHEREAS, the Pledgor has paid all of its outstanding indebtedness to the Bank secured by Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and released any and all collateral pledge, grant, assignment, lien on and security interests it has in the and to the Trademark Collateral, without warranty or recourse.

If and to the extent the Bank has acquired any right, title or interest to any of the Trademark Collateral, it hereby assigns and transfers such rights, title or interest to the Pledgor without any representation, warranties or recourse of any kind whatsoever.

The Bank shall take all further actions, and provide to the Pledgor and each of its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgor, at Pledgor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
