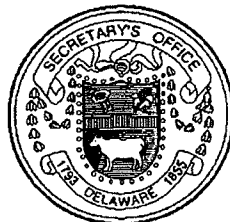

### 3. IP LICENSES

Non-Exclusive Patent License Agreement, dated as of June 15, 2008, between Joerns Healthcare Inc. (now known as Joerns Healthcare Operating LLC, a Delaware limited liability company,) (“Joerns”), and Völker AG (“Völker”), a German corporation, pursuant to which Joerns has granted Völker a non-exclusive license under its U.S. Patent No. 6,473,922, filed September 14, 2000 (the “Patent”), to make, use or sell products covered by the Patent in exchange for a payment of a royalty of \$25 USD per unit sold by Völker prior, to and during the agreement. Unless earlier terminated, the non-exclusive patent license shall terminate upon expiration of the Patent, i.e. September 14, 2020.
