## NOTICE OF SATISFACTION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **NOTICE OF SATISFACTION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT** (this "Notice") dated as of May 13, 2010 is given by WELLS FARGO BANK, NATIONAL ASSOCIATION (successor by merger to Wachovia Bank, National Association), as Administrative Agent (in such capacity, the "Administrative Agent") for the ratable benefit of the banks and other financial institutions (the "Lenders") from time to time parties to the Amended and Restated First Lien Senior Secured Credit Agreement as of April 7, 2006 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") by and among John Henry Holdings, Inc., a Delaware corporation, as borrower (the "Borrower"), Multi Packaging Solutions, Inc., as Parent, the Lenders party thereto and Wells Fargo Bank, National Association (successor by merger to Wachovia Bank, National Association), as Administrative Agent.


Pursuant to the terms of that certain Intellectual Property Security Agreement Supplement dated as of April 9, 2009 (as amended, amended and restated, supplemented or otherwise modified, the "IP Security Agreement"), MPS/IH, LLC, a wholly owned subsidiary of the Borrower, as grantor (the "Grantor"), granted to the Administrative Agent a continuing security interest in all of Grantor's right, title, and interest in, to and under the Collateral (as such term is defined in the IP Security Agreement), including without limitation those certain patents and patent applications described on Schedule A hereto and those certain trademark registrations and trademark applications described on Schedule B hereto.

The Obligations (as defined in the Credit Agreement) have been satisfied in full and any security interest of Wells Fargo Bank, National Association (successor by merger to Wachovia Bank, National Association), as Administrative Agent has been terminated, canceled and released (including, without limitation, the security interests, duly recorded on (a) April 20, 2009 in the United States Patent and Trademark Office at Reel 022562, Frame 0600 with respect to the patents and patent applications described on Schedule A hereto and (b) April 13, 2009 in the United States Patent and Trademark Office at Reel 003969, Frame 0123 with respect to the trademark registrations and trademark applications described on Schedule B hereto). All right, title and interest held by the Administrative Agent in, to and under the Collateral is hereby re-assigned to the Grantor.

The Administrative Agent represents and warrants that (x) it has the full power and authority to execute this Notice; (y) it has not assigned, transferred, restricted or otherwise encumbered any right, title or interest it has or had in, to or under any of the Collateral; and (z) it has not recorded or otherwise evidenced its security interest in the United States Patent and Trademark Office with respect to any patent or trademark, or any registration of or application to register the foregoing, owned by the Grantor other than those set forth on Schedule A and Schedule B hereto.
