


1. Release, discharge and terminate the above referenced lien and certify that the claim secured thereby has been fully paid and satisfied;

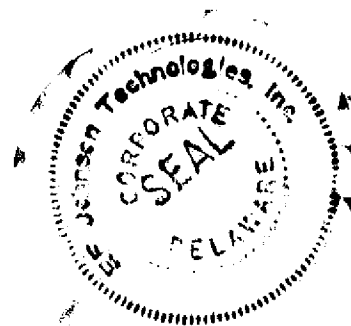
