REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is made as of 8/11, 2010 by Comerica Bank ("Bank") in favor of Universal Protection Service, LP, a California limited partnership, formerly known as Universal Security Solutions ("Grantor"), with its principal place of business at 1551 N. Tustin Avenue, Suite 650, Santa Ana, California 92705.


