REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is made as of 2/11, 2010 by Comerica Bank ("Bank") in favor of Universal Protection Security Systems, LP, a California limited partnership ("Grantor"), with its principal place of business at 1551 N.
