RELEASE OF SECURITY INTEREST IN TRADEMARK (SECOND LIEN)

This **RELEASE OF SECURITY INTEREST IN TRADEMARK**, dated as of August 12, 2010, is made by NexBank SSB, as Second Lien Administrative Agent (the "Secured Party").

WHEREAS, Endurance Business Media Holdings, LLC, Endurance Business Media, Inc., The Printing House, Inc., Homes & Land, LLC, Homes & Land Affiliates, LLC, Century Publishing Company, Inc., Frontiers Unlimited, Inc., and Pacific Publishing and Communications, Inc. (the "Grantor") granted a second lien security interest (the "Second Lien Security Interest") in certain personal property to Wachovia Bank, National Association, as Second Lien Administrative Agent (the "Initial Second Lien Administrative Agent"), including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses (the "Trademarks");

WHEREAS, the Initial Second Lien Administrative Agent assigned the Second Lien Security Interest to the Secured Party ("Second Lien Security Interest Assignment");

WHEREAS, the Second Lien Security Interest granted by the Grantor to the Initial Second Lien Administrative Agent in the Trademarks was recorded at the United States Patent and Trademark Office on July 31, 2006 at Reel 3357 and Frame 0892;

WHEREAS, the Second Lien Security Interest Assignment was recorded at the United States Patent and Trademark Office on November 7, 2008 at Reel 3884 and Frame 0337; and

WHEREAS, the Secured Party has agreed to release its security interest solely in the Trademark identified on Schedule A attached hereto (it being understood that the Secured Party's security interest in all other Trademarks shall continue in full force and effect).

NOW, THEREFORE, for valuable consideration, the Secured Party hereby releases all mortgages, liens, and security interests granted to the Secured Party by the Grantor in solely the following items:

1. the Trademark identified on Schedule A attached hereto;
2. the goodwill of the business connected with the use of, and symbolized by, the Trademark identified on Schedule A; and
3. the products and proceeds of the Trademark identified on Schedule A, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of the Trademark identified on Schedule A or (ii) injury to the goodwill associated with the Trademark identified on Schedule A.

It is expressly understood and agreed that except for the release of the Secured Party's mortgage, lien and security interest in the Trademark identified on Schedule A attached hereto


and the related items listed in clauses 2 and 3 above, nothing herein shall be deemed to be a termination or release of the Secured Party's mortgage, lien and security interest in any other collateral of the Grantor and its affiliates (including without limitation, any Trademark other than the Trademark listed on Schedule A attached hereto), and all such mortgages, liens and security interests shall continue in full force and effect.
