## CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Trademark Assignment (“**Assignment**”) is made and entered into as of August 12, 2010, by and between LANDesk Software Ltd., an Ireland company (“**LD SW Ltd**”), Crimson Holding Corp., a Delaware corporation, (“**Crimson Holding**”), LANDesk Group Limited, an Ireland company (“**LD Group**”) and Crimson Corporation (“**Crimson Corp**”)(collectively referred to as the “**Parties**”).

WHEREAS, LD SW Ltd and Crimson Holding entered into that certain Asset Transfer Agreement, dated as of May 15, 2008 (“**First Assignment**”), pursuant to which LD SW Ltd has assigned to Crimson Holding certain intellectual property rights, including any and all trademarks and trademark applications listed on the attached Schedule 1, and all goodwill of any business associated and connected therewith or symbolized thereby (collectively referred to as the “Trademarks”); and

WHEREAS, Crimson Holding subsequently entered into that certain Business Transfer Agreement with LD Group, dated as of November 7, 2008 (“**Second Assignment**”), pursuant to which Crimson Holding has assigned to LD Group certain intellectual property rights, including the Trademarks; and

WHEREAS, LD Group subsequently entered into that certain Business Transfer Agreement with Crimson Corp and Crimson Acquisition Corp., dated as of November 28, 2008 (“**Third Assignment**,” and together with the First Assignment and Second Assignment, the “**Prior Assignments**”), pursuant to which LD Group has assigned to Crimson Corp certain intellectual property rights, including the Trademarks; and

WHEREAS the Parties now desire to confirm and record the Prior Assignments in the U.S. Patent and Trademark Office;

NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. The Parties hereby confirm that, pursuant to the First Assignment, LD SW Ltd assigned to Crimson Holding all of LD SW Ltd’s right, title and interest in and to the Trademarks.
2. The Parties hereby confirm that, pursuant to the Second Assignment, Crimson Holding assigned to LD Group all of Crimson Holding’s right, title and interest in and to the Trademarks.
3. The Parties hereby confirm that, pursuant to the Third Assignment, LD Group assigned to Crimson Corp all of LD Group’s right, title and interest in and to the Trademarks.
4. Notwithstanding anything to the contrary contained herein, the Trademarks shall not include any trademark application that would be deemed invalidated, canceled or abandoned due to the contribution, assignment and/or conveyance of the Trademarks hereunder, including without limitation all United States trademark


applications that are based on an intent-to-use, unless and until such time that the contribution, assignment and/or conveyance will not cause the invalidation, cancellation or abandonment of such trademark application.

5. The Parties intend that this Assignment is for recordation purposes only, and its terms shall not modify the applicable terms and conditions of any of the Prior Assignments, which govern the Parties' rights and interests in the Trademarks.
6. This Assignment may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.




