WHEREAS, Luby's, Inc., a Delaware corporation ("Luby's"), and Assignors have entered into an Asset Purchase Agreement, dated as of June 23, 2010, as amended by that certain Amendment to Asset Purchase Agreement, dated as of July 26, 2010 (as amended, the "Asset Purchase Agreement"), and Luby's has assigned all of its rights and obligations under the Asset Purchase Agreement to Assignee;

NOW, THEREFORE, for the consideration described in the Asset Purchase Agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors do hereby assign to Assignee all rights, title, and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks and the application and registration of said Marks, including any foreign counterparts, and the right to recover any damages for past infringement, if any.


