RELEASE OF FIRST LIEN TRADEMARK SECURITY INTEREST, dated as of August 13, 2010 (this "Release"), by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as Administrative Agent and Collateral Agent (as defined below). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Guarantee and Collateral Agreement, as applicable, referred to below.

Reference is made to (i) the First Lien Credit Agreement dated as of April 26, 2007, as amended and restated as of June 12, 2007 and as further amended and restated as of March 27, 2009 (as further amended, supplemented or otherwise modified from time to time prior to the date hereof, the "Credit Agreement") among DIAMOND RESORTS CORPORATION (formerly known as Sunterra Corporation and successor by merger to DRS Acquisition Corp.), a Maryland corporation (the "Borrower"), DIAMOND RESORTS HOLDINGS, LLC, a Nevada limited liability company ("Holdings"), DIAMOND RESORTS PARENT, LLC, a Nevada limited liability company (the "Company"), the lenders party thereto and CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH (formerly known as Credit Suisse, Cayman Island Branch), as Administrative Agent and Collateral Agent, (ii) the First Lien Guarantee and Collateral Agreement dated as of April 26, 2007, as amended and restated as of June 12, 2007 (as further amended, supplemented or otherwise modified from time to time prior to the date hereof, the "Guarantee and Collateral Agreement") among SUNTERRA CORPORATION, a Maryland corporation ("Suntterra"), Holdings, the Company, the Subsidiaries of the Company from time to time party thereto and the Collateral Agent and (iii) the Trademark Security Agreement dated as of April 26, 2007 among Sunterra, the subsidiaries of Sunterra listed on Schedule I thereto and the Collateral Agent (the "Trademark Security Agreement").

WHEREAS, pursuant to the Credit Agreement, the Guarantee and Collateral Agreement and the Trademark Security Agreement, the subsidiaries of the Borrower and other related parties listed on Schedule I hereto (the "Grantors") have granted a security interest to the Collateral Agent, for the benefit of the Secured Parties in, among other things, the trademarks of the Grantors set forth on Schedule II hereto (the "Trademarks"), which security interest was recorded with the United States Patent & Trademark Office on May 14, 2007 at Reel/Frame 003540/0882.

WHEREAS, in connection with the repayment of all Indebtedness and the termination of all Commitments under the Credit Agreement, and the release of security interests under the Loan Documents, the Grantors have informed the Administrative Agent and the Collateral Agent of their desire to obtain the release of all right, title and interest of the Collateral Agent, for the benefit of Secured Parties and each other grantee or beneficiary, in and to the Trademarks granted under the Trademark Security Agreement.


NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release, cancel, relinquish and discharge any and all security interests it has against the Trademarks and reassigns all right, title and interest it has in the Trademarks to the Grantors. The Collateral Agent agree to make filings with the United States Patent and Trademark Office and take further actions, in each case as reasonably requested by the Grantors and at the sole expense of the Grantors, to evidence the release and termination of the Collateral Agent's security interests in the Trademarks. The execution and delivery of this release and any further documents and the performance of any actions by the Collateral Agent are made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE GRANTORS' AND THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.




