## RELEASE OF INTELLECTUAL PROPERTY SECURITY INTERESTS

This Release of Intellectual Property Security Interests, dated as of August 17, 2010, ("Release") is made by Wells Fargo Bank, National Association, as Administrative Agent and Collateral Agent under that certain Loan Agreement, dated as of February 29, 2008 (as amended, restated, supplemented or otherwise modified, the "Loan Agreement"), by and among Tembec Inc. ("Tembec"), Tembec Investments Inc. ("Tembec Investments"), and Tembec Industries Inc. (the "Borrower"), the lenders from time to time party thereto (the "Lenders") and Wells Fargo Bank, National Association, as Collateral Agent (the "Secured Party").

**WHEREAS**, Tembec, Tembec USA LLC ("Tembec USA"), A.R.C. Resins Corporation ("A.R.C."), and the Borrower (collectively, the "Grantors") have granted security interests in certain personal property to the Secured Party, including without limitation security interests in certain patents and patent applications, (collectively, the "Patents") and trademarks and trademark applications (collectively, the "Trademarks" and together with the Patents, the "Intellectual Property");

**WHEREAS**, the security interests granted to the Secured Party were recorded at the United States Patent and Trademark Office on March 26, 2008 and the corrective assignment dated April 9, 2008; and

**WHEREAS**, the Secured Party has agreed to terminate and release its security interests in all of the Grantors' Intellectual Property, including without limitation, the Intellectual Property identified on Schedule A hereto.

**NOW, THEREFORE**, for valuable consideration, the Secured Party hereby terminates and releases all mortgages, liens and security interests granted to the Secured Party in the following Intellectual Property:

1. all of the Intellectual Property referred to on Schedule A attached hereto;
2. all reissues, continuations or extensions of the foregoing; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantors against third parties for past, present or future infringement of any Intellectual Property.
