PARTIAL ASSIGNMENT OF TRADEMARK GRANT OF SECURITY INTEREST

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby assign to the Assignee a proportionate interest in the Secured Party's security interest in the Trademark Collateral to secure the prompt payment, performance and observance of the Obligations assigned to Assignee under the Assignment and Joinder.

Debtor does hereby join in the execution of this Assignment for the purpose of acknowledging the assignment of a partial interest in Secured Party's security interest in the Trademark Collateral as set forth herein and for the purpose of consenting to such Assignment.
