TERMINATION OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

WHEREAS, NewRiver, Inc., a Massachusetts corporation, located at 200 Brickstone Square, 5th Floor, Andover, Massachusetts 01810 (the "Debtor"), Compass Horizon Funding Company LLC, a Delaware limited liability company and Horizon Technology Funding Company V LLC, a Delaware limited liability company, each located at 76 Batterson Park Road, Farmington, Connecticut (the "Secured Parties"), entered into a certain Venture Loan and Security Agreement (the "Security Agreement"), dated as of June 28, 2008, which was recorded in the United States Patent and Trademark Office on July 14, 2008 at Reel 021253 and Frame 0149 for patents and at Reel 3818 and Frame 0148 for trademarks, that by its terms granted the Secured Parties a security interest in certain intellectual property listed in Schedules 1-A and 1-B (the "Patents") and in Schedules 1-A and 1-B (the "Trademarks") to the Security Agreement and all trademark applications, patent applications, patents and trademark registrations acquired or arising after the date of the Agreement;

WHEREAS, the Debtor has or has caused to be paid and satisfied in full the obligations for which the security interest in the Patents and Trademarks was granted.

NOW THEREFORE the Secured Parties hereby reassign to the Debtor the interest in the Patents and Trademarks listed on Schedule A and Schedule B attached hereto in which Secured Parties were granted a security interest under the Security Agreement. The Secured Parties also hereby release its security interest in the Patents and Trademarks listed in Schedule A and Schedule B attached hereto. The Secured Parties further agree, for themselves, its successors and assign, to execute such further documents and to perform such further lawful acts as may reasonably be requested by the Debtor, to effectuate this termination.
