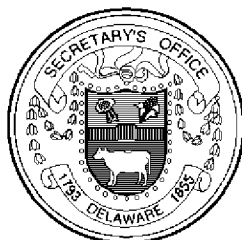

"FIRST: The name of this corporation is WHERE, Inc. (the "Corporation")."


