TERMINATION AND RELEASE OF SECURITY INTEREST

This **TERMINATION AND RELEASE OF SECURITY INTEREST**, dated as of June 18, 2010, is made by SRBA #5, L.P., a Delaware limited partnership ("Collateral Agent"), as collateral agent for each of the secured parties listed on Schedule A attached hereto (collectively, the "Secured Parties") in favor of BREACH SECURITY, INC., a Delaware corporation (the "Debtor") with its principal place of business located at 2141 Palomar Airport Road, Suite 200, Carlsbad, CA 92011.

WHEREAS, in the Security Agreement dated December 30, 2008 ("Original Security Agreement"), Debtor granted a security interest in the Collateral (as defined below) whether presently existing or hereafter created or acquired and wherever located, as defined in Paragraph 1 and described on Schedule II of the Original Security Agreement ("Collateral");

WHEREAS, the security interest granted to the Collateral Agent for the benefit of the Secured Parties was recorded at the United States Patent and Trademark Office on January 23, 2009, at Reel 022151 and Frame 0041;

WHEREAS, pursuant to an Assignment Agreement effective as of February 17, 2009, Enterprise Partners V, L.P. and Enterprise Partners VI, L.P. assigned to SRBA #5, L.P. all of their rights and obligations under the Original Security Agreement, including the right and obligation to serve as collateral agent;

WHEREAS, the Original Security Agreement was amended and restated on May 8, 2009 ("Amended and Restated Security Agreement"); and

WHEREAS, Debtor has no outstanding obligations to Collateral Agent and Secured Parties under the terms of the Original Security Agreement and Amended and Restated Security Agreement, and Collateral Agent has agreed to terminate and release its security interest in the Collateral under these agreements, including, without limitation, the patents and trademarks identified on Schedule B attached hereto.

NOW, THEREFORE, for valuable consideration, Collateral Agent hereby terminates and releases all security interests granted to the Collateral Agent for the benefit of the Secured Parties in all right, title and interest of Debtor in and to the Collateral and reassigns to Debtor, without warranty or recourse, all right, title and interest of Debtor in and to the Collateral. Collateral Agent authorizes the Debtor, or its agent, to terminate any financing statement on file in favor of the Collateral Agent.
