**TERMINATION AND RELEASE  
OF  
SECURITY AGREEMENT**

**TERMINATION AND RELEASE OF SECURITY AGREEMENT**, dated as of August 20, 2010, from Jay Weil, as collateral agent (the "Collateral Agent") to Nexxus Lighting, Inc., a Delaware corporation (the "Company").

**WHEREAS**, pursuant to the terms of that certain Security Agreement dated June 18, 2009 between the Collateral Agent and the Company, recorded with the U.S. Patent and Trademark Office on June 25, 2009 at Trademark Reel 4011 and Frame 0233; the Company granted to the Secured Parties (as such term is defined in the Security Agreement) a security interest in and lien on, and collaterally assigned to such Secured Parties all of the Company's trademarks, service marks and applications for trademarks and service marks, including, but not limited to, the trademarks and applications to register trademarks listed on Schedule A attached hereto and made a part hereof, all common law rights in the trade marks, service marks and trade names subject to such registrations, all statutory rights that may attach to any registrations thereof and any related renewals, and all related good will (such trademarks referred to herein as the "Named Trademarks"); and

**WHEREAS**, all of the Company's obligations under the Notes and Purchase Agreement (as such terms are defined in the Security Agreement) have been satisfied;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates and releases the Secured Parties' (as such term is defined in the Security Agreement) security interest in and first priority lien on all of the Company's Named Trademarks, and the Collateral Agent hereby assigns and transfers to the Company, without recourse, all of such Secured Parties' right, title and interest in and to each of the Named Trademarks and the related trademark registrations and goodwill, effective as of the date set forth above.

**IN WITNESS WHEREOF**, the Collateral Agent has executed this Termination and Release, to take effect as of the date first set forth above.
