**ASSIGNMENT OF TRADEMARK COLLATERAL ASSIGNMENT  
(First Lien)**

This ASSIGNMENT OF TRADEMARK COLLATERAL ASSIGNMENT dated as of August 19 2010 is made by Wells Fargo Bank, N.A., as resigning Administrative Agent, with an office at 45 Broadway, 14th Floor, New York, New York 10006, Attn: Mr. Julius Zamora (“Wells Fargo”), in favor of Wilmington Trust FSB, with an office at 50 South Sixth Street, Minneapolis, MN 55402, Attn: Jeffery Rose, as successor Administrative Agent (the “Assignee”).

WHEREAS, Bank of America, N.A. (“Bank of America”) was the initial Administrative Agent pursuant to a Trademark Collateral Assignment (First Lien) dated as of February 16, 2007 (the “Trademark Collateral Assignment”) made by Green Valley Ranch Gaming, LLC, a Nevada limited liability company (the “Grantor”) in favor of Bank of America, for the benefit of Secured Party (as defined therein), as to the trademark collateral described below;

WHEREAS, pursuant to an Omnibus Amendment, Appointment and Acceptance dated as of November 3, 2009 (the “2009 Appointment Agreement”) between Bank of America and Wells Fargo, Wells Fargo succeeded to all rights, powers, privileges and duties of Bank of America in its capacity as Administrative Agent under the Trademark Collateral Assignment and related loan documents;

WHEREAS, pursuant to an Omnibus Amendment, Appointment and Acceptance dated as of even date herewith (the “Agreement”) between Wells Fargo and Assignee, Assignee has succeeded to all rights, powers, privileges and duties of Wells Fargo in its capacity as Administrative Agent under the Trademark Collateral Assignment and related loan documents;

WHEREAS, the Trademark Collateral Assignment covers certain trademarks, trade names, trade styles and service marks, including those trademarks and registrations listed on Schedule 1 attached hereto, and was recorded on February 16, 2007, at Trademark Reel 3482, Frame 0921, in the United States Patent and Trademark Office;


WHEREAS, pursuant to the Agreement, Wells Fargo desires to execute this assignment in favor of Assignee.
