**ASSIGNMENT OF TRADEMARK  
AND ACCOMPANYING GOODWILL**

WHEREAS, FENNER DUNLOP AMERICAS, INC., a corporation duly organized and existing under the laws of the State of Delaware and having its principal place of business at 8720 Red Oak Boulevard, Suite 510, Charlotte, North Carolina 28217 (hereinafter "Assignor"), has used in commerce the standard character trademarks, FIRE BOSS, FIRE BOSS PREMIUM and FIRE BOSS ULTRA (collectively referred to herein as "the Marks") and registered the Marks on the Principal Register in the United States Patent and Trademark Office as described on attached Schedule A; and

WHEREAS, J. H. FENNER & CO. LIMITED, a limited liability company organized and existing under the laws of the United Kingdom and having its principal place of business at Hesslewood Country Office Park, Ferriby Road, Hessle, East Yorkshire HU130PW, England (hereinafter "Assignee"), is desirous of acquiring any and all rights that Assignor may have in the goodwill of the business in connection with which the Marks are used and which is symbolized by the Marks, along with the right to recover for damages and profits for past infringements thereof.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign unto Assignee all rights, title and interest in and to the Marks, together with the goodwill of the business in connection with which the Marks are used and which are symbolized by the Marks, along with any and all interests, claims and rights for damages and profits by reason of any past infringement or unauthorized use of the Marks, false designations of origin, unfair competition, deceptive trade practices and/or dilution related to the Marks, use of confusingly similar marks or names by others and all other related causes of action and the right to sue therefor.

Assignor further agrees to execute and deliver at the request of Assignee, all documents, instruments and assignments, and to perform any other reasonable acts Assignee may require in order to vest all Assignor's rights, title, and interest in and to the Marks in Assignee in any jurisdiction and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.
