## TRADEMARK ASSIGNMENT

This assignment shall include the applications to register the Marks, along with any other applications or registrations for the Marks and the right to prosecute such applications or any new application for the Marks, and enjoy the benefits of any registrations resulting therefrom.

Assignor affirms and warrants that it has made and shall make no conflicting transfer of any of the Marks or of any right, title, or interest therein, and that it has not and shall not create or permit any encumbrance thereon.

Assignor hereby covenants and agrees to and with Assignee, its successors, legal representatives and assigns that Assignor will, at the cost and expense of the Assignee, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the recordation of this assignment of the Marks to and for the benefit of the Assignee.

Assignor hereby requests all other trademark officials and offices to issue, to Assignee, any and all registrations, as applicable to such officials or offices, on or arising from the Marks or any of them, for use and benefit of the Assignee, its successors, legal representatives, and assigns.

This Assignment of Trademarks is being delivered in connections with the Agreement and Plan of Merger and is subject to, and is entitled to the benefits in respect of, the Agreement and Plan of Merger.

This Assignment of Trademarks shall be binding upon and inure to the benefit of Assignor and Assignee and their respective successors and assigns.

This Assignment of Trademarks may be executed in two or more counterparts, each of which shall be deemed an original and all of which shall constitute one instrument.

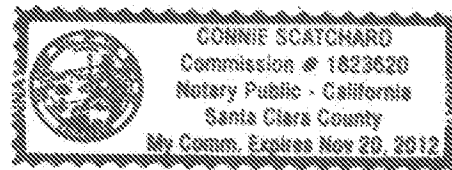

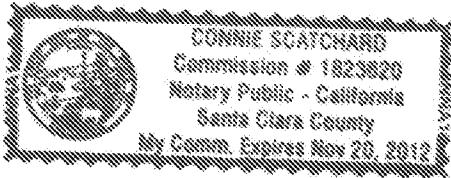
