FULL RELEASE AND RECONVEYANCE OF SECURITY INTERESTS

This FULL RELEASE AND RECONVEYANCE OF SECURITY INTERESTS (the "Release") is granted by BANK OF AMERICA, N.A., a national association, successor in interest to LaSalle Business Credit, Inc., ("Secured Party"), with an address of One Centerpointe Drive, Suite 500, Lake Oswego, Oregon 97035, secured party to a certain Trademark Security Agreement (the "Agreement") granted on December 16, 2002 by The Cookson Company, a California corporation, Cookson Door Sales of South Carolina, Inc., a South Carolina corporation, and Southland Door Systems, a California corporation (hereinafter referred to together as "Grantor"). The release is granted in favor of States Industries, Inc., ("Releasee") an Oregon Corporation with an address of P.O. Box 7037, Eugene, Oregon 97401.

WHEREAS, the Grantor by the Agreement granted to the Secured Party, as security for the full and prompt payment of obligations arising under a loan agreement between Secured Party and Grantor, a security interest in various marks which was subsequently recorded in United States Patent and Trademark Office against trademark registration number 2675934 for the mark ARMORCORE (the "Trademark Collateral"); and

WHEREAS, Releasee and not Grantor was and is the actual and record owner of the Trademark Collateral at the time of the Agreement; and

WHEREAS, the Trademark Security Agreement did not refer to or apply to the Trademark Collateral, and was not intended by Grantor, Releasee, or the Secured Party to refer to such, and so the Agreement was recorded against the Trademark Collateral in error; and

WHEREAS, the Secured Party erroneously filed the Trademark Security Agreement against the Trademark Collateral with the United States Patent and Trademark Office, recorded on January 30, 2003 at Reel 2756, Frame 0353; and

NOW, THEREFORE, in consideration of this error and as a result of other satisfactory consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby releases and withdraws the security interest granted in the Trademark Collateral, Reg. No. 2675934, and recorded at Reel/Frame 2756/0353, and conveys to the extent of its interest therein, if any, without recourse, representation or warranty of any kind to the Releasee, in any and all Trademark Collateral transferred by the Trademark Security Agreement.

FURTHERMORE, this Release does not apply to the security agreement recorded at Reel/Frame 2737/0275, notwithstanding the fact that the same Trademark Collateral is referenced in both recordings.
