Pursuant to the provisions of Sections 14-2-1001 and 14-2-1002 of the Georgia Business Corporation Code (the "Code"), Definition 6, Inc., a Georgia corporation (the "Corporation") hereby submits this Amendment to the Articles of Incorporation of the Corporation:

FIRST: The name of the corporation is Definition 6, Inc.

SECOND: Article 1 of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following is substituted in lieu thereof:

"1.

The name of the Corporation is Michon, Inc. (the "Corporation")."

THIRD: The amendment herein provided for was duly adopted by the board of directors of the Corporation as of December 26, 1999, without shareholder action.

FOURTH: Pursuant to Section 14-2-1002 of the Code, shareholder action was not required.

FIFTH: A request for publication of notice of intent to file articles of amendment to change the name of the Corporation and payment therefor shall be made as required by Section 14-2-1006.1(b) of the Code.

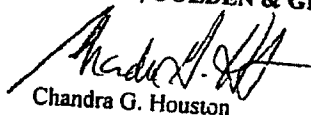
