Assignor further agrees, without further consideration, to take such further action and execute such further assignment and other lawful documents as Assignee may reasonably request to effectuate fully this Assignment.


Assignor authorizes and requests the Commissioner of Trademarks to record Assignee as the assignee and owner of all rights, title and interest in the Trademarks.
