RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated this 13 day of August, 2010 (this "Release") is made by KeyBank National Association, a National Banking Association with a place of business at 127 Public Square, Cleveland, Ohio 44114 (the "Secured Party") of a Trademark Collateral Assignment and Security Agreement dated January 26, 2000 and recorded on February 1, 2000 in the records of the United States Patent and Trademark Office Assignment Branch at Trademark Reel/Frame 2025/0247 (the "Security Agreement"), by and among Huffy Corporation; Royce Union Bicycle Company; American Sports Design Company; Huffy Service First, Inc.; Washington Inventory Service; and Huffy Brands Company (the "Debtors") and KeyBank National Association.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, the Debtors granted to the Secured Party, on behalf of itself and as agent for certain other lenders, a security interest in certain of Debtors' United States trademarks and trademark applications and registrations and, in particular, the trademarks set forth on the attached Schedule A (the "Trademarks"); and

WHEREAS, the Secured Party wishes to: (i) release all of its security interest covering the Trademarks; (ii) restore all right, title, and interest held by the Secured Party in and to the Trademarks to the Debtors; and (iii) dissolve any and all liens and encumbrances of the Secured Party respecting the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Trademarks, and discharges, quitclaims and relinquishes unto Debtors without recourse and without representation or warranty of any kind or nature, express or implied, any and all rights, title and interest it has in and to the Trademarks.
