ASSIGNMENT OF TRADEMARKS

WHEREAS RCN TELECOM SERVICES, INC. WHEREAS, Yankee Cable Acquisition, LLC, Yankee Metro Parent, Inc., Yankee Metro Merger Sub, Inc. and RCN Corporation entered into that certain Agreement and Plan of Merger dated as of March 5, 2010, as amended (the "Merger Agreement");

WHEREAS RCN TELECOM SERVICES, LLC ("Assignee"), a Delaware limited liability company, having an address at 196 Van Buren Street, Suite 300, Herndon, Virginia 20170, pursuant to the transactions contemplated by the Merger Agreement is succeeding to the business to which the Trademarks and Applications pertain;

WHEREAS, pursuant to the Merger Agreement the Assignor shall merge with and into RCN Telecom Services (Lehigh) LLC (the "Lehigh Merger"), which shall be a wholly-owned subsidiary of Assignee;

WHEREAS, for administrative convenience Assignee wishes to acquire from Assignor certain assets of Assignor, including the Trademarks, the Applications and Registrations, and the goodwill of the business symbolized by the Trademarks, prior to the consummation of the Lehigh Merger.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound, Assignor hereby assigns, conveys and transfers to Assignee all right, title and interest in and to the Trademarks, the Applications and Registrations, any other applications and registrations of the Trademarks, and the goodwill of the business symbolized by the Trademarks, to be held and enjoyed by Assignee for its own use and benefit and for its successors and assigns as the same would have been held by Assignor had this assignment not been made.
