WHEREAS, Assignor has adopted and used in the United States and worldwide the Marks identified in the attached list, Appendix A, and the applications and/or registrations therefor for the goods and services listed therein, as well as other goods and services relating to the golf business, and owns the entire right, title, and interest in and to each of said Marks and the U.S. applications and registrations for each of them together with all of the goodwill of the business symbolized thereby; and,

WHEREAS, Assignee desires to acquire all of Assignor's right, title and interest, in and to the Marks, applications and registrations together with all the goodwill of the business symbolized thereby, and Assignor desires to assign all such right, title and interest in and to the Marks, applications and registrations to Assignee, upon the terms and conditions stated herein,

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged by Assignor, the parties agree as follows:

Assignor hereby conveys and assigns to Assignee, all of Assignor's right, title and interest in and to the Marks listed in Appendix A hereto, together with the goodwill of the business symbolized by the Marks.

1. Assignor represents that (i) it owns the entire right, title and interest in and to the Marks, (ii) that the applications and/or registrations thereof are currently valid and subsisting and in full force and effect, (iii) it has not licensed any of the Marks to any other person or entity or granted, either expressly or impliedly, any trademark rights with respect to any of the Marks to any other person or entity, (iv) it has all authority necessary to enter into this Assignment, and the execution and delivery of this Assignment have been duly and validly authorized, and (v) its execution of this Assignment and performance of its obligations hereunder shall not violate or conflict with any other agreement to which it is a party.

2. At any time, and from time to time after the Effective Date, at Assignee's request, Assignor shall execute and deliver such other instruments of sale, transfer, conveyance, assignment and confirmation and take such other action as Assignee may reasonably deem necessary or desirable to perfect or otherwise enable this transfer, conveyance and assignment to Assignee and to confirm Assignee's title to any of the Marks and any and all federal and state trademark registrations thereof or applications therefor, and to assist Assignee in exercising all rights with respect thereto. Assignor further agrees to provide such reasonable cooperation and assistance to Assignee, as Assignee may request, to enforce its rights in the Marks.

3. After the Effective Date, Assignor agrees not to challenge Assignee's use or ownership, or the validity, of the Marks.


