Agent and the Lenders hereby agree and acknowledge that upon Agent's receipt from the Borrower prior to 2:00 p.m. Toronto time on August 3, 2010 or on such later date on or before August 11, 2010 on which the payoff is made prior to 2:00 p.m. Toronto time (the "Payoff Date") of (i) the amounts, plus any applicable Per Diem (as hereinafter defined), outstanding under the Credit Documents (in each case, as identified on Schedule 1 attached hereto, collectively, the "Payoff Amount"), and (ii) a fully executed counterpart of this letter agreement (the "Agreement") signed by the Borrower and each other Credit Party (the time at which all of the conditions in the foregoing clauses (i) and (ii) shall first be satisfied is herein referred to as the "Payoff Effective Time"):
  - (a) all outstanding indebtedness of the Borrower and the Credit Parties to Agent and Lenders (including, without limitation, for principal, interest and fees) and other



Obligations of the Borrower and the Credit Parties to Agent and Lenders under or relating to the Credit Documents shall be paid and satisfied in full and irrevocably discharged, terminated and released, except that nothing contained herein shall, or shall be deemed to, cancel, impair or otherwise limit the obligations and liabilities of the Borrower or the Credit Parties under any indemnity provisions or any other provisions of the Credit Documents which, by their terms, expressly survive the termination of the Credit Documents or the payment of the Obligations and under any provisions of any Credit Document which are necessary for the enforcement by Agent or the Lenders of any such surviving obligations and liabilities;




