TRADEMARK ASSIGNMENT

WHEREAS, ASSIGNOR desires to assign, convey, transfer, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the Trademark.

NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby assigns, conveys, transfers, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Trademark, together with (1) the goodwill of ASSIGNOR'S business relating to the products and services for which the Trademark is used; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Trademark, including, without limitation, damages and payments for past and/or future infringements and misappropriations of the Trademark; and (3) all rights to sue for past, present and/or future infringements or misappropriations of the Trademark.

ASSIGNOR warrants that it is the sole and exclusive owner of the Trademark; that it has not transferred, assigned, or granted any share, interest, license, assignment or any other right in or to the Trademark to any third party; and that the Trademark is free and clear of any liens, encumbrances or restrictions held by any third party.

This Assignment constitutes the legally binding Bill of Sale from ASSIGNOR to ASSIGNEE, and ASSIGNOR covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Trademark. Furthermore, ASSIGNOR hereby irrevocably constitutes and appoints ASSIGNEE as its true and lawful attorney, authorized to take all actions that ASSIGNEE may deem proper in order to vest, perfect and confirm in ASSIGNEE clear and exclusive title to the Trademark and to otherwise to carry out the provisions of this Agreement, which power of attorney is coupled with an interest and, therefore, is not revocable in any manner or for any reason by ASSIGNOR.

The undersigned officers of ASSIGNOR and ASSIGNEE warrant that they are duly authorized on behalf of their respective companies to execute this Assignment.
