Release of Security Interest in and Lien on Trademarks

This Release of Security Interest in and Lien on Trademarks ("Release"), dated as of August 18, 2010, is made by KPS Capital Finance Management, LLC in its capacity as agent for Lenders (as defined below) ("Agent") in favor of Chase Brass and Copper Company, LLC ("CB&C") and GBC Metals, LLC, as successor to Global Metals, LLC ("GBC Metals" and together with CB&C, "Grantors").

WHEREAS, pursuant to (i) the Term Loan and Security Agreement dated November 19, 2007 among Grantors, Global Brass and Copper, Inc., Chase Brass, LLC, A.J. Oster, LLC, the guarantors party thereto, Agent, and certain other financial institutions named as lenders therein ("Lenders"), (ii) the Trademark Security Agreement dated November 19, 2007 between Agent and CB&C, and (iii) the Trademark Security Agreement dated November 19, 2007 between Agent and GBC Metals, Grantors granted to Agent for the benefit of itself and the Lenders a security interest in and lien on all right, title and interest of the Grantors in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Trademarks");

WHEREAS, the security interest in and liens on the Trademarks granted to the Agent were recorded in the United States Patent and Trademark Office on November 27, 2007 at Reel 3667, Frame 0570 and Reel 3667, Frame 0508; and

WHEREAS, Agent has agreed to release any and all security interest in and lien on the Trademarks held by the Agent for the benefit of itself and the Lenders.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Agent does hereby release, relinquish and discharge its security interest in and lien on the Trademarks and reassigns to Grantors any and all of Agent's right, title and interest in and to the Trademarks.
