RELEASE OF SECURITY INTEREST  
IN TRADEMARKS



Agent hereby reserves all of its rights and remedies under the Agreement with respect to any trademarks and trademark applications (other than the Released Marks), and all goodwill associated therewith, in which a security interest was granted under the Agreement and was not heretofore released or discharged by Agent.
